- Understanding of applicable reclamation regulations and regulatory guiding documents.
- Any equivalent combination of training, education, and experience that provides the required skills, knowledge and abilities.

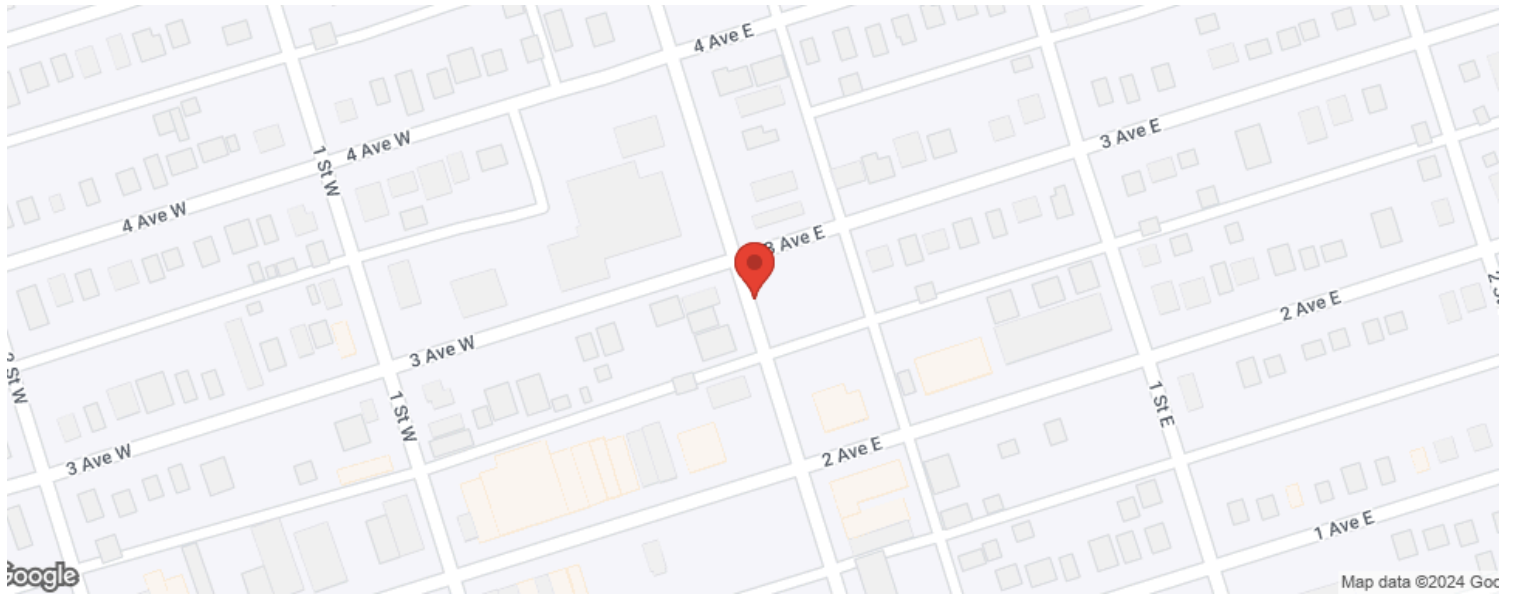
